GUIDELINES FOR ISSUE OF VISA

1. Applications to be sent along with passport, 2 coloured photographs and visa fee payable by cash or bank draft.

Personal cheques will not be accepted, if correct amount is not enclosed, application will not be processed.

2. If passport is to be received by mail, the courier service may be informed to collect it from this office.
3. A copy of airline ticket or confirmed itinerary duly stamped by airlines or travel agency should be enclosed.
4. Latest bank statements showing balance of F\$5000 each person.
5. A copy of supporting letter in case of following visas:

Student Visa : A letter from University for a confirmed admission.

Business Visa : An invitation letter from the company in India.

Conference Visa : An invitation letter from the organization in India.

Please provide a copy of recent bank statement as supporting document to your application.

6. The persons of Indian origin visiting India to meet their relatives must write the complete address of relatives in India in the application form.
7. No separate application / photograph / visa fee is required for child / children entered in the parent's passport.
8. Applicants applying for long-term visa must mention their period of stay in India.
9. All visa fees and postage are subject to change.

GUIDELINES FOR ISSUE OF MEDICAL VISA
(KIDNEY PATIENT/DONOR)

1. Valid Passport & 2-passport size colour photos.
2. Local doctor's letter in original.
3. Indian doctor's letter of confirmation for date of admission, cost of treatment and treatment time (Days/Months) for the patient.
4. Please provide a recent personal bank statement of patient as supporting document to your application OR if fully financed by Ministry or an Insurance Company and their covering letter stating of financial support.
5. A copy of airline ticket or confirmed itinerary duly stamped by Travel Agency or airlines should be enclosed.
6. Employees of Government sectors are required to enclose leave letters in original.
7. Patient can only be accompanied by 2 persons and they all should register themselves with relevant authorities (FRRO) upon arrival in India.
8. Lodgment of visa to be done 1-2 weeks ahead of flight date.
9. Donor needs to submit an additional form, birth certificate and documents to support blood relation with the patient.
10. Application Fee- \$115.00-per applicant on Fijian Passport
